REQUEST FOR QUOTATION – SNOW CLEARING

The Town of Red Hook is requesting Quotations for snow/ice clearing operations for approximately 2000 linear feet of sidewalk on the West Side of Route 9 in the Town of Red Hook. The sidewalk runs from Conway’s Lawn & Power Equipment property to the Colburn Building. Snow clearing will also be required for approximately 2100 linear feet of sidewalk on the East Side of Route 9 from the Town Hall to the Holy Cow business. In addition, you will clear approximately 1200 linear feet of sidewalk on Hannaford Drive. This sidewalk runs from Route 9 past the last Hannaford building. You will also be asked to clear and salt the Red Hook Town Hall parking lot and walkways as well as to clear and salt the Town recycling center.

The contractor shall:

1. Remove snow from the sidewalk by blower, plow, or hand within twenty-four hours after snowfall.
2. Snow shall be removed if an accumulation of 2 inches or more occurs or at the direction of the Highway Superintendent, Theresa Burke. Snow shall be blown or plowed in such a manner as to not create a hazardous condition to roadways, parking lots, or property along the sidewalk.
3. In the event of slippery or ice conditions, the sidewalks shall be de-iced with material(urea) obtained from the Highway storage area at Glen Pond Road. The de-icing shall occur as needed or at the direction of the Highway Superintendent.
4. The contract period shall be from November 1, 2020 through October 2021.

A. Contractors are asked to quote on a per event basis:

1. Costs to remove all snow from the 5500 feet of sidewalk and Town Hall Walkways \$ _____.
2. Cost to de-ice the 5500 feet of sidewalk and Town Hall Walkways \$ _____.
3. Cost to remove all snow at the Town Hall and Recycling Center parking lots \$ _____.
4. Cost to de-ice Town Hall and Recycling Center parking lots \$ _____.

B. Contractors must file a Certificate of Insurance (Minimum Liability, \$1,000,000 and Workers Compensation Insurance) if awarded the contract.
